- The project has already been under review since 2018, and we cannot afford to wait another year just to gain approval. We urge the Council and Staff to approve SB 35 streamlining if Eden requests it. Potential improvements can be addressed at the Staff level since this is a code-compliant project.

- One architectural design improvement that we'd like to see considered is to make windows wider if possible.
 This would not only make the building aesthetically more appealing but also help save energy by allowing more natural light into the apartments.
- We appreciate that the site is close to the Community Shuttle and MVGo Shuttle routes. However, we are
 concerned that limitations of these transit options will not allow most residents to live car-free. We encourage
 the City to accelerate the implementation of improvements identified by the Shuttle Study and go beyond them
 by reducing headways to 10 minutes or less, extending hours of operation, streamlining routes, and
 consolidating Community Shuttle and MVGo systems.

 allowing more natural light into the apartments.
- We appreciate that the site is close to the Community Shuttle and MVGo Shuttle routes. However, we are
 concerned that limitations of these transit options will not allow most residents to live car-free. We
 encourage the City to accelerate the implementation of improvements identified by the Shuttle Study and

go beyond them by reducing headways to 10 minutes or less, extending hours of operation, streamlining routes, and consolidating Community Shuttle and MVGo systems.



Dear Honorable Mayor Abe-Koga and Members of the City Council:

As the owner of Shoreline Boulevard, LH Shoreline LP is proud be part of the Mountain View community. We are also excited to be bringing 303 new homes, including 40 new Below Market Rate homes, to the Terra Bella mixed-use neighborhood. With housing located directly adjacent to an office building, with thousands of jobs and other uses in the immediate vicinity, parking is a critical resource that must be fairly regulated for all potential users to enjoy appropriately.

The safety and security of all residents and neighborhoods is rightfully a top priority in Mountain View. To this end, in late 2019 the City Council adopted an Ordinance that restricted the parking of oversized vehicles on streets of 40' in width or less. In November's election, Mountain View residents decisively voted to confirm this Ordinance and now Council must act to enforce the new rules.


The streets abutting Shoreline are currently wider than 40' and thus have been excluded from the Resolution before Council tonight. However, as you know, the City plans to construct a dedicated bus lane along Shoreline Boulevard starting in early 2021. As part of this project, the intersection of Shoreline Boulevard and Terra Bella Avenue will be reconstructed and narrowed to 40' with a new crosswalk incorporating bulb-outs for pedestrian safety. Because Terra Bella Ave will then meet the City's definition of a "narrow street," we respectfully request that the City Council amend Table 19.79.4 in the Resolution to include Terra Bella Avenue, from Shoreline Blvd to San Rafael Ave, in the list of streets incorporating the new parking restrictions. Linda Vista Avenue, north of Terra Bella Avenue, which already meets the requirements, should also be included.



I know that a majority of Mountain View residents do not want RVs parked in front of their homes. Is appropriating a million dollars to put up signs the best solution? I wonder if the cost of this program had been published prior to vote casting if MV residents would have thought this was the best use of their tax dollars.

I also think that there is probably a huge difference in the costs of some of implementing the actual signage. On my block of Whisman Road we have two signs. One was fastened to an existing streetlight pole. The second sign involved the following process:

Within a week of the election, two "no parking" a-frame signs were delivered curbside in front of my neighbor's house. The sidewalk was spray-painted with various symbols. Two men in a truck did the work. The following day, two men in a truck arrived and proceeded to jack-hammer a hole in the middle of one of the two sidewalk squares. They then placed a metal pole in the sidewalk with the new "no parking" RV sign. They took away the A-frame signs.



The passage of Measure C and the plans to begin the enforcement of the new parking regulations before the holidays have prompted me to write and urge you to delay the beginning of enforcement until after Santa Clara County is out of the COVID purple tier.

Enforcement of Measure C will require the combined efforts of city staff, city police, the Community Service Agency, and other Mountain View nonprofits and community groups. According to the press release put out by the city on November 17, 2020, the city intends to begin enforcement as early as the 18th of December. The city plans to "...conduct outreach to individuals..." who live in RVs and oversized vehicles. The city also plans to "...provide options for where they can go." Although this sounds straightforward on paper, it will be a massive undertaking on the part of a large group of people.

It is unsafe to bring together large groups of people for something that can be delayed until the county has given the "all clear" for gathering groups of people. The enforcement of Measure C has the potential to become a super spreader event and put the city's first responders and community volunteers, not to mention all of the unhoused and underhoused Mountain View residents, in increased danger of contracting the virus, an already vulnerable group of residents. Every person who contracts the virus risks infecting members of their family, coworkers, and the community at large.

Therefore, I strongly urge you to postpone enforcement of this ordinance.


I'm writing today to urge you to move slowly on implementation of Measure C enforcement.


A few additional notes:

The above said, we strongly urge you to choose among alternatives that will allow the longest time for implementation and to apply affected funds on other programs and projects needed for those in the community who are housing-challenged meanwhile. For example, the launching of the DignityMoves (Homekey) project on Leghorn Street is expected to come online in the near future, and this should reduce some of the need for vehicle dwellers to continue parking on our streets. Also, allowing more time could enable the City to select bids on the lower end of the cost spectrum and to save on labor costs for overtime and weekend work, and the highest level of Staff-time flexibility will be ensured.

To save on City expenses, we feel that using contractors (rather than City personnel) for the needed work should be avoided, at least as much as possible, and locking in contracts with contractors could effectively decrease City spending flexibility in the long run.

We are not pleased with the possibility that CIP projects could be negatively impacted by this project. As you know, timeliness for completion of CIP projects is not ideal as it is, and further negative impacts would exacerbate this.

Related to the signs, the ones we have seen on North Whisman Road (at least) are posted fairly far into the sidewalk space. This poses an additional impediment to pedestrians passing through, and we already know our city sidewalks are often not all that wide to begin with. This approach certainly does not comply with the requirement that the signs be installed in "unobstructed locations".


