SUBJECT: Pedestrian Master Plan – Annual Review

RECOMMENDATION

Review and provide comments regarding the current Pedestrian Master Plan and the upcoming Active Transportation Plan.

BACKGROUND

When the City Council approved revisions to the PMP at its January 28, 2014 meeting, Council directed the Bicycle/Pedestrian Advisory Committee (B/PAC) to include an annual review of the PMP in its work plan.

On November 10, 2020, Councilmembers directed staff to combine the PMP update with the update of the Bicycle Transportation Plan (BTP) to allow for the alignment of competing uses within public rights-of-way for key corridors within the City. Taking a more holistic approach allows for the planning of all modes more cohesively and efficiently, ensuring quality transportation options for all modes of travel. Council also directed staff to incorporate considerations related to green streets and habitat corridors arising from new biodiversity requirements in the ATP.

The purpose of this discussion is to provide B/PAC members with an opportunity to:

- Provide general comments on the PMP's adequacy in addressing the pedestrianrelated needs of the community;
- Identify topics, issues, and concerns that should be considered for inclusion in the ATP, which will serve as the update of the PMP as well as the BTP; and
- Review the draft list of tasks under consideration for the ATP, which combines both the PMP Update and BTP Update.

ANALYSIS

Summaries of comments received at past annual reviews are included in Attachment 1. Staff has also distilled comments from B/PAC's past reviews of the PMP from 2015 through 2021 as displayed in Table 1. Items have been summarized and consolidated, and are listed by year and completion status. As displayed below, many items are recommended for consideration in the upcoming ATP. Additionally, some items have already been completed or are under way, while others may not be best addressed through the ATP.
