Vice Chair Lin attended a community gathering event hosted by the Mountain View Police Department on October 4.

Commissioner Ball noted that Pfizer submitted its COVID-19 vaccine for FDA approval for children 5-11 years old.

Assistant City Manager Ramberg shared that Assembly Bill 315 allows local governments to make monthly findings to allow City Council and Advisory Bodies to meet remotely during the COVID-19 pandemic.
