# RECOMMENDATION

- 1. Accept the public improvements for the development at 277 Fairchild Drive for maintenance throughout their useful life.
- 2. Accept the public improvements for the development at 2500 Grant Road for maintenance throughout their useful life.
- 3. Accept the public improvements for the development at 315-319 Sierra Vista Avenue for maintenance throughout their useful life.
- 4. Accept the public improvements for the development at 554 San Antonio Road for maintenance throughout their useful life.

# BACKGROUND AND ANALYSIS

"Acceptance" of developer-installed improvements signifies that the developer has satisfactorily completed improvements in the City's right-of-way. Once accepted, the City takes ownership of and maintenance responsibility for the improvements.

# 277 Fairchild Drive

This development project included a 26-unit rowhouse complex and two common lots for private streets and open space. The public improvement plans for this development were approved for construction on June 21, 2018.

The public improvements include:

### 2500 Grant Road

This development project at El Camino Hospital included: a new two-story, 56,000 square foot behavioral health services building; a new seven-story, 265,000 square foot integrated medical office building; a new five-level, 390-stall parking structure adjacent to the new medical office building; a four-level, 430-stall addition to the existing four-level North Garage parking structure and an expansion of the existing service yard. The public improvement plans for this development were approved for construction on January 24, 2018.

### 315-319 Sierra Vista Avenue

This development project included a 15-unit rowhouse complex and two common lots for private streets and open space. The public improvement plans for this development were approved for construction on October 21, 2019.

This development project included the conversion of an existing 12,386 square foot vacant commercial building into an office building. The public improvement plans for this development were approved for construction on September 28, 2020.
