#### **Tang**

- Receive the SRO Manual and MOU and provide input and solicit community feedback.
- Examine State Auditor's report or related legislative recommendations on bias/extremist views in policing; ensure extremism is not present at MVPD.

## **Brodovsky**

 Examine why and how traffic stops could be done without the police in Mountain View.

### Langton

 Receive an update and presentation on staffing levels and recruiting and retention at MVPD.

#### **Aiyar**

- Receive the SRO Manual and provide input and solicit community feedback.
- Examine State Auditor's report or related Assembly Person Ash Kalra's bill recommendations on bias/extremist views in policing.

### Wang

• Examine substance abuse in the community and student populations and provide recommendations on how to combat the problem.
