CITY OF MOUNTAIN VIEW RESOLUTION NO. SERIES 2022

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW TO VACATE PUBLIC EASEMENTS AT 870 EAST EL CAMINO REAL

BE IT RESOLVED by the City Council of the City of Mountain View as follows:

1. That pursuant to and in accordance with the provisions of Part 3 of Division 9 (Sections 8300 through 8374) of the Streets and Highways Code of the State of California (the Public Streets, Highways, and Service Easements Vacation Law), the City Council does hereby declare Council's intention to vacate public easements at 870 East El Camino Real in the City of Mountain View. The legal description and plat of the easements to be vacated, describing the particulars of the proposed vacation, a copy of which is on file in the City Clerk's Office of the City of Mountain View, are also attached hereto as Exhibits A and B, and incorporated herein by reference.

2. That notice is hereby given that at the hour of 6:30 p.m., or as soon thereafter as the matter can be heard, on Tuesday, September 13, 2022, a public hearing will be held by the City Council in accordance with California Government Code Section 54953(e) as authorized by resolution of the City Council, by video conference, at which time and place all persons interested in or objecting to the proposed vacation may appear and be heard. Participation by video conference will be through the Zoom Webinar by visiting <u>mountainview.gov/meeting</u> and entering Webinar ID: 843 5126 7142, or as otherwise provided on the posted City Council Agenda.

3. That the City Clerk is hereby directed to publish this Resolution at least 14 days prior to said hearing, pursuant to Section 8322 of the Streets and Highways Code of the State of California.

4. That copies of this Resolution, serving as notice of vacation, shall be conspicuously posted by the Public Works Director along the line of the aforesaid public easements proposed to be vacated at least 14 days before the date set for hearing; the notices shall be posted not more than 300' apart, but at least three notices shall be posted along the line of the public

easements proposed to be vacated, pursuant to Section 8323 of the Streets and Highways Code of the State of California.


