# 5.1 El Camino Real Pedestrian and Bike Improvements, Project 20-61-Heritage Tree Mitigation

M/S Sommer/Filios - To forward a recommendation for a replacement at a 5:1 mitigation ratio with the preference that at least two of the replacement trees be located on site at 96 West El Camino Real and the remaining replacement trees be located within the CalTrans medians in Mountain View or along the El Camino corridor somewhere in locations that are in need of trees, and the tree list to be as specified in the staff report, which consists of two canopy trees and two under story trees that may also be increasing the greenery of the El Camino corridor.
