## CITY OF MOUNTAIN VIEW RESOLUTION NO. 18798 SERIES 2023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW:

(1) APPROPRIATING AND INCREASING EXPENDITURES BY \$95,975 IN THE

GENERAL NON-OPERATING FUND FOR WORKFORCE DEVELOPMENT

AND JOB TRAINING PROGRAMS; (2) AUTHORIZING THE CITY MANAGER OR DESIGNEE TO

NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH

WORKING PARTNERSHIPS USA TO PROVIDE THE TRADES ORIENTATION PROGRAM TO

MOUNTAIN VIEW RESIDENTS IN AN AMOUNT NOT TO EXCEED \$100,000;

AND (3) AUTHORIZING EXECUTION OF OTHER RELATED AGREEMENTS AS NECESSARY

FOR THE DISBURSEMENT OF THE FUNDING

WHEREAS, during the course of a fiscal year, the City Council may take actions that change or modify the City's existing and approved budgets; and

WHEREAS, the City Council approved the appropriation of \$500,000 in American Rescue Plan Act funding to support job training and workforce development programs in the Fiscal Year 2022-23 Adopted Budget and directed staff to develop a recommendation for the allocation of this one-time funding source; and

WHEREAS, requests for workforce development funding totaled \$595,975, exceeding the appropriation authorized by the City Council; and

WHEREAS, all of the funding requests advance the Council's Strategic Priorities of Community for All and Economic Vitality and provide critical workforce development and job training opportunities to Mountain View's most vulnerable residents; now, therefore, be it

RESOLVED: by the City Council of the City of Mountain View that the recitals set forth above are true and correct and hereby incorporated by this reference as if fully set forth in their entirety; and be it

FURTHER RESOLVED: that the following stated amount is hereby appropriated:

General Non-Operating Fund—Expenditure Increase of \$97,975; and be it

FURTHER RESOLVED: that the City Council of the City of Mountain View hereby authorizes the City Manager or designee to execute an agreement with Working Partnerships USA for workforce development programs in an amount not to exceed \$100,000; and be it

FURTHER RESOLVED: that the City Council of the City of Mountain View hereby authorizes the City Manager or designee to execute related agreements as reasonably necessary to disburse the funding to grantees; and be it

FURTHER RESOLVED: that this Resolution shall be effective upon the date of its adoption.
