5. UNFINISHED BUSINESS

Bystander Intervention Training Subcommittee

Commissioners Poicon and Webb provided the update. The training has moved to June and the subcommittee is working with the Council on American Islamic Relations to confirm availability.

6. NEW BUSINESS

Fiscal Year 2023-24 Work Plan Development Discussion

Principal Management Analyst James provided an overview of the work plan process and an FY 22-23 HRC Work Plan update to the Commission and facilitated the discussion regarding potential FY 23-24 HRC Work Plan projects. The Commission discussed the following potential topics and projects for consideration in the next fiscal year's work plan:

- Language accessibility beyond minimum legal requirements – process; the ability for local/neighborhood groups to access services.*
- Refugee settlement informational report and discussion.*
- Mobile home parks - bring an event as a Commission to create more connection with the City.*
- Resilient Mountain View - work w/ City staff to assist with Climate Change Vulnerability Assessment community outreach.*
- Carry forward FY 22-23 mental health work to hold a follow-up event/workshop in partnership with Community Health Awareness Council.*
- We Are Mountain View - solicit community stories for display (online or location) and a possible event. Collect stories over several months in set formats and multiple languages.*
- Experiences of gender in MV – organize an event facilitated by a single speaker with expertise on all aspects of gender followed by a Civility Round Table discussion.*
- Hold a second Candidly Speaking event (can be connected to specific topic/ideas).*
- Carry forward mental health work to a follow-up event to offer coping skills/resources/support.*
