thence along said northerly line, South 83°06'18" East, 12.00 feet to the westerly line of a 25 foot drainage easement as described in Book 3679 at Page 401, recorded December 7, 1956, Official Records of Santa Clara County;

thence along said westerly line, South 06°54'42" West, 318.12 feet to the **TRUE POINT OF BEGINNING**.




