- A Resolution Recommending that the City Council Approve a Zoning Map Amendment for the Properties Located at 801/805/809/813 El Camino Real West and 1032/1044/1060 Castro Street from the CRA (Commercial/ Residential-Arterial) Zoning District to the P (Planned Community) Zoning District; and
- A Resolution Recommending that the City Council Approve a Planned Community Permit and Development Review Permit for a Mixed-Use Project With 164 Apartment Units and 10,800 Square Feet of Commercial

Space, and a Heritage Tree Removal Permit for the Removal of Three Heritage Trees at 801 El Camino Real West.
