A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW ACCEPTING THE SANTA CLARA COUNTY REGISTRAR OF VOTERS CERTIFICATION OF SUFFICIENCY OF "THE COMMUNITY STABILIZATION AND FAIR RENT ACT CHARTER AMENDMENT" INITIATIVE PETITION

WHEREAS, on April 1, 2016, the City Clerk received the Request for Preparation of Ballot Title and Summary of Proposed Charter Amendment, Notice of Intent to Circulate an Initiative entitled The Community Stabilization and Fair Rent Charter Amendment, and text of the proposed initiative and proponents' certifications as required by Election Code § 9608; and

WHEREAS, on April 13, 2016, the City Clerk provided the proponents with the Ballot Title and Summary prepared by the City Attorney; and

WHEREAS, on June 14, 2016, the City Clerk received The Community Stabilization and Fair Rent Act Charter Amendment Initiative Petition (Initiative Petition); and

WHEREAS, an amendment of a city charter proposed by a petition signed by 15 percent of the registered voters of the City, equal to 4,671, must be submitted to the voters at a General Municipal Election; and

WHEREAS, after conducting a prima facie review, the City Clerk determined that the petition contained 7,311 signatures, and the initiative petition was deemed filed on June 15, 2016; and

WHEREAS, on June 15, 2016, the City Clerk retained the services of the Santa Clara County Registrar of Voters to conduct the required examination of the Initiative Petition and the validity of the signatures thereon; and

WHEREAS, the Santa Clara County Registrar of Voters examined the Initiative Petition and on July 14, 2016, determined that the Initiative Petition was signed by the requisite number of qualified voters and was sufficient because it contained 5,848 valid signatures and provided the City Clerk with the Clerk's Certificate to Initiative Petition, attached hereto as Exhibit A; and

WHEREAS, Elections Code § 9114 requires the elections official to certify the results of the examination of Initiative Petitions to the City Council at the next Regular City Council Meeting following the certification;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Mountain View hereby accepts the Clerk's Certificate to Initiative Petition for The Community Stabilization and Fair Rent Charter Amendment, attached hereto as Exhibit A.
