TITLE: 2018 Council Meeting Schedule

RECOMMENDATION

Confirm the schedule for City Council meetings and Study Sessions for the 2018 calendar year.

BACKGROUND AND ANALYSIS

The following schedule is intended to be a "master calendar" for City Council meetings for calendar year 2018. In general, the schedule calls for the Regular City Council meetings to be held the second and fourth Tuesdays of the month with one or two Special City Council meetings per month scheduled on the alternate Tuesdays in order to consider regular City business items and/or conduct Study Sessions. Study Sessions will also be scheduled prior to or after Council meetings when possible. In addition, the schedule provides for a summer and holiday season "meeting break" per Council practice.

This schedule takes into consideration known potential conflicts (listed on Page 2); however, Councilmembers are encouraged to let staff know in advance of any other conflicts and bring their calendars to the meeting in the event that the item is pulled for discussion or changes.

In 2017, a total of 33 meetings will be held. In 2018, 32 are proposed. Based on the above assumptions, the proposed meeting schedule is as follows:
