# 5. NEW BUSINESS

### 5.1 Funding recommendations for Fiscal Year 2018-19 CDBG and **HOME Capital Project Funding Requests.**

Associate Planner Yesenia Jimenez gave a staff report on the guidelines for use of CDBG and HOME funds, summarized the applications, and provided direction for public hearing protocols.

CDBG/HOME Applicants commented on their proposals.

Motion - M/S - To recommend to City Council to approve staff's recommendation for the allocation of \$332,000 of CDBG funding, allocating \$20,000 to Rebuilding Together Peninsula for the Safe At Home Project, \$120,000 to Hope's Corner Inc. for the Removal of Architectural Barriers Project, and \$192,000 to MidPen Housing for the New Units at Shorebreeze Apartments Project, and an allocation of \$171,000 of HOME funding to MidPen Housing for the New Units at Shorebreeze Apartments Project. If additional CDBG funds become available in any amount, the Commission recommends that funding be made available to Rebuilding Together Peninsula, Hope's Corner Inc., and MidPen Housing.
