Re: Updated "Sending Site" for San Antonio Area School Site

Dear Dan,

After extensive consideration and good faith negotiations to find an optimal solution for all parties as part of the process of acquiring a new public school for LASD in the San Antonio area, LASD is pleased to propose an update to the previously identified "Sending Site," approved by the City Council on January 16, 2018, on the following terms:

- As shown on the attached map, the proposed "Sending Site" for the TDR Program would move from the three parcels located at 2580 and 2590 California Street and 201 San Antonio Road ("Old Mill/Safeway Site) to an approximately 9.65 acre site on California Street and Showers Drive ("Federal Site").
- LASD will acquire the Federal Site through condemnation from Federal Realty Investment Trust ("Federal") for the future development of a new school and public park.
- Greystar, which has applied for a Planned Community Permit and Master Plan for the Old Mill/Safeway Site, would concurrently acquire approximately 2.00 acres directly adjacent to the Federal Site from Federal to dedicate in fee to the City for future parkland, as partial satisfaction of its Park Fee obligation (~3.86 acres) from its proposed mixed-use development on the Old Mill/Safeway Site that is currently scheduled for City Council consideration on June 26, 2018. This additional 2.00 acres of future parkland space would be in addition to the joint open space / recreational facilities at the new school.
- No other changes are proposed to the TDR Program and MOU approved by the City Council (e.g., no additional TDRs, no change to the existing TDR Gatekeeper requests other than the identification of the sending site, no change to the City's proposed contribution of park fees, etc.)
