Direct staff to incorporate the study of La Avenida as a potential site for the bridge.

Following discussion, Boardmember Abe-Koga modified the motion to revise the language in Table 1, North Bayshore Precise Plan Transportation Implementation Actions, Future Transit Facility, to include a transit hub: "As these studies recommend preferred routes or technologies, identify necessary transit facility space, including a transit hub, and location needs based on direction from the Board."

Boardmember Rosenberg agreed to the modification.
