

## Project description for Large Family Child Care Home AUG 3 1 2018

Facility address: 1880 Miramonte Ave, Mountain View, 94040 CA.

PLANNING DIVISION

Age and total number of children: Care for 9 to 14 children: 2-10 years of age. Not more than 2 school age children may be accommodated. There are 2 kids under the age of 10 living in caregiver's household: 2 and 8 years of age. They will be counted to the total number of children enrolled in the Child Care Home. Besides of the children living in the house care will be provided for 11 children 2-5 years of age and 1 child 6-10 years of age.

**Infants:** Care will be provided to **no children under the age of 2**, besides of the children that may be born in the caregiver's family. Caregiver is aware that not more than 4 children under 2 years of age may be accommodated.

Operating hours: 8am-6pm, Monday-Friday, with observation of all major holidays.

Employees: 1 employee besides of the caregiver to be employed.

**Parking:** 2 parking spaces in the garage dimensioned 9' x 20' are available for the main residence. One parking space for the employee not living in the residence with the dimensions 8.5' x 18' is available on the driveway.

Backyard/Outdoor Play Area/Fence: Outdoor Play Area is located in the backyard which is set back from adjoining residential dwellings and enclosed with a 6 foot wood fence.

Protective screen for fireplace: Protective screen for fireplace is installed in living room.

**Exits:** There are 2 exits from play room/ living room area: first - main entrance door towards Miramonte Ave, second - towards the kitchen with exit to the backyard for emergency situations (see enclosed facility sketch).

Smoke and carbon monoxide alarms locations: See enclosed facility sketch.

Fire extinguisher location: See enclosed facility sketch.

Access: Easy access to the facility with 4 lanes road.

Competitors: There are no Large Family Child Care Homes located on borders of 1880

Miramonte Ave.

Poisoning Industries: There are no poisoning industries in the neighborhood.

**State issued license:** Caregiver has gone through necessary training and has submitted all documents required for California Child Care Provider License. At the moment the license is still not obtained as the required background check takes up to 3 months.

Business license from City of Mountain View: Caregiver will obtain a business license from City Of Mountain View prior to starting operating the Child Care.
