6.1 Recommendations for FY 2019-20 Community Development Block Grant (CDBG) and General Fund Public Service Funding Requests

Housing and Neighborhood Services Manager Tim Wong gave a staff report on the guidelines for use of CDBG and General Fund Public Services funds, summarized the applications, and provided direction for public hearing protocols.

CDBG/General Fund Public Service applicants commented on their proposals.

Motion -M/S - Stone/Batton - To recommend to the City Council to approve staff's recommendation for \$90,000 of CDBG Public Service Program funding. If additional CDBG funds or program income is made available in any amount, the Commission recommends allocating any excess amount of CDBG funds proportionally to the applicants up to their requested amount.
