#### 2. Briefly describe the project or program that you are proposing.

This capital project request is to replace the HVAC system of the CHAC Clinic at 590 ELC MV. The 30- year old system is the original system with several non-functional compressors. Staff and clients are uncomfortable throughout the year. Regrettably, space heaters are needed to heat the offices. Therefore, energy costs are high because the few working components are straining to heat or cool the entire building. The system is at risk of complete failure and cannot be effectively repaired.

#### 3. What are the groups that will be targeted by your project or program?

CHAC's mission is to provide and champion comprehensive, quality, innovative and affordable mental health services in our service area for those in need. Our vision is that everyone in our community embraces mental health and wellness as integral to a healthy fulfilled life. With no stigma attached to mental health services, we help people know where and how to access appropriate help. We work towards universal access to a continuum of mental health services that includes prevention and intervention.

#### Low Income Clients

· 41% of CHAC's individual counseling clients report household income of less than \$35,000 per year.

- 59% report household income of less than \$65,000 per year
- 30% of the FRC's families qualify to live in government subsidized housing.
- Approximately 41% of CHAC's clients report Hispanic/Latinx as their ethnicity and

• 43% report ethnicity of other than Caucasian or Hispanic/Latinx. CHAC served over 14,000 clients in FY 2017-2018 including individuals and families, as well as school-setting children as individuals and in social emotional learning groups.

CHAC fees are based on a self-reported income sliding fee scale that ranges from \$20 to \$130 per session. However, CHAC sees clients regardless of ability to pay, even on the sliding fee scale by raising donor funds to subsidize clients who cannot afford any fee. CHAC provides a critical safety-net for local residents who may have limited or high deductible insurance plans, Medi-Cal/ Affordable Care Act covered clients and clients with no insurance at all. Without CHAC, these clients would have to rely on the County Mental Health Department where access is extremely impacted.

Utilization

• 780 clients receive counseling services in the Mountain View clinic;

• 3,200 students receive individual counseling in CHAC's school-based sites;

• 1,300 students participate in school based social emotional learning programs offered in Kindergarten, 3rd grade and 5th grade;

• 9,000 clients (an average of 450+ parents/families per month) receive services and/or participate in FRC programs.

47 % of our clients served at the CHAC Mountain View clinic are Mountain View residents.

CHAC's programs address four major areas:

• Clients experiencing anxiety, depression, domestic violence, substance abuse and other issues receive Individual, family and group counseling at the Mountain View Clinic. Also offered are parenting groups, LGBTQI support, a culturally focused Latinx program; and substance abuse/addiction recovery support groups.

• Neuro -Psychological evaluation is available at the Mountain View Clinic for a variety of issues including learning disabilities, attention deficit memory and language development difficulties.

• CHAC's Family Resource Centers (FRC), help parents and other caregivers of children aged 0-5 years understand the importance of physical and social-emotional development starting in the early years in life; we offer parent-child Interactive classes, parenting education, child development screenings, community events, parent coaching, coaching programs for childcare and other providers, community service resource & referral, and community engagement programs.

• CHAC's school-based individual counseling and evidence-based social emotional learning programs for K-12 students in 34 area schools including all Mountain View Whisman School District and MVLA high schools. Students and families needing longer-term care beyond CHAC's school programs are referred to the Mountain View Clinic.

We offer services in 13 languages to ensure that clients for whom English is not their first language have access to services in their native language. We offer translation services for clients and our Latinx program specifically supports language services and acculturation needs of our clients.

During the initial meeting with a client, we ask clients to voluntarily report race/ethnicity data on our intake form which is then entered into our Electronic Health Record system under demographics. They are able to "decline to identify".

During our intake process, we discuss our fee schedule with clients and ask them to self-report their income category based on that schedule. If a client responds that even the sliding scale visit fee is not affordable, we may ask for income verification and then make further adjustments that may be as low as no fee at all for services.

### 11. Describe the need that the proposed project or activity addresses and its community impact.

This project extends the effective life of the CHAC facility located at 965 W. El Camino Real in Mountain View and allows CHAC to continue to provide services in this location as described below.

12. What other private or government organizations are now or will be addressing the same needs identified herein? Explain how the proposed activity augments rather than duplicates the services of other organizations. There are other agencies and providers of mental health services in Santa Clara County. Examples include the Bill Wilson Center, the Santa Clara County Mental Health Department, Uplift Family Services and the Children's Health Council. These agencies serve populations who may be covered by Medi-Cal or other public reimbursement. CHAC serves the population who's income is not low enough to qualify for public programs yet their income is insufficient to be able to afford the services of private clinicians. In addition, CHAC serves low income clients who do qualify for public programs cannot necessarily access them due to long wait lists. Many private practice providers do not accept public reimbursement and, in fact, do not accept insurance at all. CHAC also serves privately insured patients who cannot afford the cost of "cash pay only" private

practitioners perhaps due to the financial stresses brought on by their mental health issues or other life issues that have caused them to seek our services.

### **Project Information**

## 13. Describe the project's target population, including client eligibility requirements. Discuss how and if they are an at-risk and/or under-served population.

In today's world, anyone can be at risk for a variety of conditions that require access to mental health services including depression, anxiety, substance abuse and addiction, neuropsychological issues or learning disabilities to name a few. The American Psychological Association estimates that 16.2 million American adults, have had at least one major depressive episode in a given year.

In Mountain View, according to the Santa Clara County Department of Public health, approximately 13% of the adult population, or 7,125 people have been diagnosed with a depression disorder and 13% also reported episodes of binge drinking. Nine percent of Mountain View adults reported in this 2018 survey that they had suffered a major episode of mental distress within the past 30 days prior to the survey.

According to the National Alliance on Mental Illness (NAMI) and the National Institute for Mental Health (NIMH), approximately 1 in 5 youth aged 13–18 (21.4%) experiences a severe mental disorder at some point during their life. For children aged 8–15, the estimate is 13%. Further, half of mental health conditions begin by age 14, and 75% of mental health conditions develop by age 24. In September 2018, the Mountain View Voice newspaper published, "Nowhere to Turn for Kids in Crisis" where it described the mental health service referral program at Los Altos High School. Students can place a concern about themselves or a friend anonymously in a referral box which the school then follows up. The article states, "About five years ago, the number of annual referrals tallied up to about 200. By last year it had quadrupled to more than 800."

Communities across California are experiencing a growing shortage of licensed mental health clinicians due to retirements, insurance system financial pressure, lack of child and adolescent specialists and lack of affordable housing. With private providers shifting to cash based practice (vs. insurance) and over-burdened public system providers, CHAC's target population falls into the coverage and access gap for the Santa Clara County mid-peninsula region. Our clients may have no insurance, Medi-Cal or an Affordable Care Act plan that private providers refuse while County public providers have long wait lists for access. Other clients may be in a personal crisis where financial issues make private insurance co-pays and deductibles unaffordable. CHAC provides clinic services using an income-based sliding fee schedule (\$20-\$130) but strives to accept clients regardless of their ability to pay. A client may pay as little as \$1 per visit.

Replacing the HVAC system at the CHAC Mountain View clinic on El Camino Real is a critical need in terms of maintaining the facility, extending its useful life, and assuring the ability of staff to work with clients in an environment that is both comfortable and safe (in terms of the impact of extreme heat or cold). CHAC does not have eligibility requirements to receive services other than a client's clinical need for mental health services including individual or group counseling, early childhood development/family and parenting support, suicide prevention, substance abuse recovery and other supportive services, all of which are offered at our Mountain View clinic.

In addition, CHAC is also one of the largest training programs in the Bay Area for marriage and family therapists (MFT) and post-graduate PhD/PsyD psychologists; we annually train 75 -80 of the area's future mental health providers. Placement in our American Psychological Association accredited training program is competitive and highly sought-after by students and graduates to complete their supervised internships. CHAC therapists and their supervisors gather at the main clinic weekly for didactic training programs and required supervisory sessions, all of which require a location with a working HVAC system.

In FY 2018, CHAC serviced 13,743 clients and provided 45,736 service hours across all of its programs in at school sites, the family resource center, and the Mountain View Clinic. CHAC served 781 clients at the Mountain View clinic. The number of clients seen annually varies based on severity of client issues that directly impacts the number of visits required. At this time, we anticipate serving approximately the same number of clients at the Mountain View Clinic during FY 19. Replacing the HVAC system would not, on its own, increase our capacity and throughput. However, it will allow CHAC more scheduling flexibility as some of our treatment rooms are unusable during periods of extreme temperature. Scheduling flexibility may lead to some client intake increases, however, this project is focused on the ability to maintain our building to better serve current clients and staff.

### 20. Briefly describe your agency's mission and history.

For 46 years (since 1973), CHAC has carried out a mission of providing alternatives to self-destructive behavior, and creating healthy lives for the children and families of Mountain View, Los Altos, Los Altos Hills and the surrounding communities by providing counseling and other mental health services. In addition to services in our Mountain View clinic building, CHAC provides mental health services to more than 3200 students in 34 schools in 4 school area districts including the Mountain View Whisman, Mountain View-Los Altos High School, Los Altos and Sunnyvale Elementary school districts.

One of CHAC's identified strategic goals is to assure cultural sensitivity and diversity awareness among all of our clinicians and staff. CHAC management strives to keep this goal at the forefront of clinical, operational and management practices and strongly believes the agency's actions help to reduce the stigma associated with seeking emotional support services that exists across many cultures.

CHAC's programs address four major areas, all of which contribute to stronger communities:

• Individual, family and group counseling at the Mountain View Clinic location including parenting groups, LGBTQI support, a culturally focused Latinx program;

• Specialty programs including Well Within that address substance abuse recovery in a family-based model and psychological evaluation for a variety of issues including learning disabilities, attention deficit memory and language development difficulties;

• CHAC Family Resource Centers (FRC), a collaboration among CHAC, FIRST 5 Santa Clara County and other community partners to offer programs that help parents and other caregivers of children aged 0-5 years understand the importance of physical and social-emotional development starting in the early years in life including parent-child Interactive classes, parenting education, child development screenings, community events, parent coaching, coaching programs for childcare and other providers, community service resource & referral, and community engagement programs; and

• CHAC school-based individual counseling and social emotional learning programs for K-12 students including Second Step (Kindergarten), Just for Kids (3rd Grade), What's Trending (pilot program for 5th graders) and Tween Talk (5th grade- 8th) grade.

In FY2018, CHAC therapists and FRC volunteers provided 45,736 hours of clinic, FRC and school-based services to our midpeninsula communities that served 13,700 clients.

The CHAC clinic building located at 590 W. El Camino Real, was built in 1986-1987 and, today, still has the original HVAC system. The heating/air conditioning system consists of 8 units, 4 installed on each corner of the roof and 4 installed in ceiling space between the first and second story of the building. Two of the 8 units are entirely non- functional and several others are on their "last legs." In this situation, the working units are having to operating constantly to compensate for the failing ones. The system is not effectively maintaining consistent temperature throughout the building. The last contractor

contacted for repairs stated that the system is now beyond partial fixes.

#### 21. How will the effectiveness of your project/activity be measured?

Replacement of CHAC's HVAC system will extend the useful life of CHAC's main clinic building located at 590 W. El Camino Real, one of the main access roads to Mountain View. Anecdotally, we expect a reduction in client and staff complaints related to the interior temperature. In addition, the system will be brought up to current code requirements as the current system was installed approximately 30 years ago. Finally, CHAC will be able to directly measure if the system is resulting in a reduction of energy costs for the agency although we are not able to project those savings ahead of the installation because of the age of the existing system.

A mental health diagnosis may negatively affect an individual's productivity and earning power, which can cause absenteeism and unemployment while having secondary effects on families, colleagues and neighborhoods and, in some cases, entire communities.

In 2017, the Santa Clara County Homeless Census & Survey identified 416 homeless residents in Mountain View, a 51% increase over the 2015 survey. Thirty-eight percent of the respondents indicated that they had been diagnosed with psychiatric or emotional conditions. CHAC is available for the Mountain View homeless community when they choose to seek Mental Health assistance.

Another CHAC priority is supporting stronger families and development of parenting skills that ultimately leads to stronger neighborhoods and communities. CHAC offers individual and family counseling for families in crisis that may be divorce, immigration or housing insecurity, a child with special needs or learning disabilities, grief, and trauma, etc.
