Donald Trump, et al., United States District Court for the District of Maryland, Case No. 1:18 cv 03636 ELH, Consideration of whether to participate in this litigation as amicus curiae in support of plaintiff City of Baltimore: in furtherance of the City's goal to support vulnerable members of the community the City Council decided that the City of Mountain View would join the friend of the court brief to support the City of Baltimore in their challenge against the Trump Administration regarding immigration policies. City Attorney Quinn reported the vote was 5 yes, 1 no by Councilmember McAlister, and Councilmember Clark was absent.
