Mayor Matichak added Council interest in historic preservation throughout the Precise Plan.

City Manager Rich summarized that there is general consensus to amend targeted areas on a Precise Plan-wide basis, and stated the next steps will be staff coming back to Council with a work plan, budget, and timeline.

Council provided input on the draft Position Paper for the Cities Association of Santa Clara County regarding the CASA Housing Compact: add support for identification of sensitive communities and communities vulnerable to displacement, and policy planning to protect these communities; urge the addition of policy planning for emergency measures to address houselessness and homelessness; add language regarding the jobs-housing balance; add language regarding avoidance of regressive taxation and unfunded mandates; add language referencing cities who have created a lot of housing; the language regarding transportation should include something independent of housing; add more emphasis that the private sector should build their own workforce housing; change the word "investments" to "revenue measures;" and stronger wording regarding no loss of local control as it pertains to land use.
