The Subcommittee provided input and comments on potential amendments to the Community Stabilization and Fair Rent Act and issues to consider:

- The relationship between the Rental Housing Committee and the City.
- Rent stabilization for mobile homes (by separate ordinance).
- Streamlined Capital Improvement petition process (such as soft story retrofits).
- Use the opportunity to propose other changes to the City Charter if necessary.
- The cost implications of a March 2020 versus November 2020 ballot measure.
- Form a sustainable, high level Charter (consider certain items to be voted on by super majority of City Council).
- Make the CSFRA as workable as possible, without having to make amendments every two years.

By consensus, Subcommittee members recommended targeting a March 2020 ballot measure, but to leave the final decision on the ballot date to later in the process, and agreed to the proposed process timeline as presented in the staff report, with the following edits:

- Hold the second subcommittee meeting to consider input from stakeholders and the public after the Rental Housing Committee meeting on August 12, 2019 and direct staff to poll subcommittee members for availability the week of August 19, 2019.
- Change the date of Council's first consideration of the item from September 24, 2019 to another date and direct staff to poll Council for a possible special Council meeting date of September 17, 2019.
