TITLE: 100 Moffett Boulevard – Accept

Public Improvements

RECOMMENDATION

Accept the public improvements for the development at 100 Moffett Boulevard for maintenance throughout their useful lives.

BACKGROUND

The public improvement plans for the 184-unit apartment complex were approved for construction on December 3, 2014.

2,400 SF	Sidewalk
295 SF	Upgraded Driveway
75 LF	Curb and Gutter
3 EA	Curb Ramp
30 EA	Street Trees
