Chair Solomon thanked Vice Chair Sylvester for chairing the meeting in her absence.

Commissioner Romero shared that there are approximately 50 Mountain View residents who speak an indigenous dialect from Oaxaca, Mexico who may need translation assistance when completing the Census in 2020.
