A RESOLUTION DESIGNATING STREETS, OR PORTIONS THEREOF, WHERE OVERSIZED VEHICLE PARKING ADJACENT TO CLASS II BIKEWAYS IS PROHIBITED PURSUANT TO MOUNTAIN VIEW CITY CODE SECTION 19.79.3

WHEREAS, the Mountain View City Code prohibits and restricts parking under various circumstances pursuant to Chapter 19 of the Mountain View City Code; and

WHEREAS, Section 19.79.3 of the Mountain View City Code provides that Council may designate, by resolution, the locations where the parking of oversized vehicles adjacent to Class II bikeways is prohibited and restricted; and

WHEREAS, the City of Mountain View desires to add a table of streets, or portions thereof, designating such locations;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mountain View that the parking of oversized vehicles adjacent to Class II bikeways at the following designated locations is prohibited, consistent with the City Code Section 19.79.3:
