RESOLUTION OF INTENTION

TO APPROVE AN AMENDMENT TO CONTRACT

BETWEEN THE

BOARD OF ADMINISTRATION CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM

AND THE

CITY COUNCIL CITY OF MOUNTAIN VIEW

- WHEREAS, the Public Employees' Retirement Law permits the participation of public agencies and their employees in the Public Employees' Retirement System by the execution of a contract, and sets forth the procedure by which said public agencies may elect to subject themselves and their employees to amendments to said Law; and
- WHEREAS, one of the steps in the procedures to amend this contract is the adoption by the governing body of the public agency of a resolution giving notice of its intention to approve an amendment to said contract, which resolution shall contain a summary of the change proposed in said contract; and
- WHEREAS, the following is a statement of the proposed change:

To end Section 20516 (Employee Sharing Cost of Additional Benefits) applicable to applicable to Section 21362.2 (3% @ 50) effective July 8, 2001, Section 21548 (Pre-Retirement Option 2W Death Benefit) and Section 21547.7 (Alternate Death Benefit for Local Fire Members Credited with 20 or More Years of Service) effective June 14, 2009 for classic local fire members; and

to provide Section 20516 (Employees Sharing Additional Cost) of 3.5% for classic local miscellaneous members in the EAGLES Employee Organization, 4.25% for new local miscellaneous members in the EAGLES Employee Organization; 3.7% for classic local miscellaneous members in the Mountain View Police Officers' Association, 4.45% for new local miscellaneous members in the Mountain View Police Officers' Association; 6.148% for classic local police members in the Mountain View Police Officers' Association; 6.148% for classic local police members in the Mountain View Police Officers' Association, 2.898% for NEW local police members in the Mountain View Police Officers' Association; 3.5% for classic local miscellaneous members in the Service Employees International Union, AFL-CIO, 4.25% for new local miscellaneous members in the Service Employees International Union, AFL-CIO; 8.366% for classic local fire members in the Mountain View Professional Firefighters, 2.366% for
