Adopt Ordinance No. 5.20, an Amendment to Ordinance No. 2.20, an Urgency Ordinance of the City of Mountain View Temporarily Suspending Evictions for Nonpayment of Rent by Residential Tenants Impacted by the COVID-19 Emergency Extending the Duration of the Ordinance to August 31, 2020, read in title only, further reading waived, effective immediately upon adoption.

Councilmember Matichak suggested an amendment to the motion to extend the payback period to 180 days.

City Attorney Chopra stated for the record the sections of the ordinance to be amended: the title of the ordinance to change the date from June 30, 2020 to August 31, 2020; the opening paragraph of Section 2 to change the date from June 30, 2020 to August 31, 2020; and Section 2(e) and 2(f) to change the payback period from 120 days to 180 days.

Councilmember Matichak reported her attendance at meetings of the BAWSCA Board and Santa Clara/Santa Cruz Airplane Noise Roundtable. Councilmember Matichak reported that there is a vacancy on the Rental Housing Committee and encouraged member of the public to apply.

City Clerk Natusch stated the Clerk's Office will coordinate the recruitment to fill the vacancy.

Vice Mayor Kamei reported her attendance at a meeting of the Community Health Awareness Council (CHAC) Board and a community conversation hosted by CHAC.

Mayor Abe-Koga reported her attendance at a weekly meeting with County Supervisor Simitian and County Supervisor Chavez regarding COVID-19 test sites and reported two pop-up test sites held in Mountain View.

Mayor Abe-Koga reported her attendance at a meeting with County Supervisor Chavez and other agencies regarding encouraging telecommuting following the end of the shelter in place order.
