Public Improvements

RECOMMENDATION

1. Accept the public improvements for the development at 257-279 Calderon Avenue for maintenance throughout their useful lives.

2. Accept the public improvements for the development at 100 and 420-430 Ferguson Drive for maintenance throughout their useful lives.

BACKGROUND AND ANALYSIS

"Acceptance" of developer-installed improvements signifies that the developer has satisfactorily completed improvements in the City's right-of-way. Once accepted, the City takes ownership of and maintenance responsibility for the improvements.

257-279 Calderon Avenue

This development included a 16-unit rowhouse complex and two common lots for the private streets and open space. The public improvement plans for the project were approved for construction on June 20, 2019.
