Member Brodovsky shared with the PSAB that 25% of MVHS students are Latino, 3% are Black.

Member Wang explained that she supports combining her efforts to interview students of color with Chair Aiyar's efforts to do the same.

Vice Chair Frink shared his work gathering experiences and research of the MVPD SRO program and had spoken with or was planning on speaking with administrators at both MVLA and MVWSD.

Chair Aiyar shared that she met with SROs and was planning additional further meetings with them and invited the Board to do the same.

Member Langton asked about how to contact the SROs.

Member Brodovsky shared that in South Carolina a HS she is aware of has three (3) officers assigned to arrest students and asked about the contrast to the MVPS SRO program.

Vice Chair Frink shared his experience with SROs in Orlando and other areas.

Member Langton asked about what The City can do to encourage board members and volunteers to be vaccinated.
