Housing Insecurity Subcommittee

Chair Sylvester provided the update. The subcommittee is preparing for an event on May 25th at which unstably housed community members will share their stories. The subcommittee has reeached out to community groups working with unstably housed residents.

Member of the public Rajiv Mehta inquired about the purpose of the event. Chair Sylvester responded that its purpose is to bring people in the community together to build

connections, understand the many ways to be unstably housed, and share stories of housing instability more broadly.

Mental Health Subcommittee

Vice Chair Nwokidu provided the update. The subcommittee is developing a format and identifying partners for an event that will include practical exercises. The event is tentatively planned for June 2023.

Chair Sylvester reported on the closeout of the History of Housing project. Oral history interviews will be digitally archived on the City website and physically archived in the Library History Center.

Commissioner Webb and Chair Sylvester expressed appreciation and gratitude for former Commissioner Solomon's work on the project.

Chair Sylvester announced that she is beginning a new role at the Los Altos Mountain View Community Foundation. She also shared that applications are being accepted for the one vacant position on the HRC.
