4.2 <u>Shoreline Boulevard Adaptive Signal System, Project 13-30 - Approve Plans/Specifications and Authorize Bidding.</u>

- 1. Approve plans and specifications for the Shoreline Boulevard Adaptive Signal System, Project 13-30, and authorize staff to advertise the project for bids.
- 2. Authorize the City Manager to award the construction contract to the lowest responsible bidder if the low bid is within the project budget.
- 3. Transfer and appropriate \$248,000 from the Shoreline Regional Park Community Fund to the Shoreline Boulevard Adaptive Signal System, Project 13-30. (Five votes required)
