- Guest permits at the rate of \$5 per month.

- Continuation of data gathering which would require ongoing staff time
- Contract via the City or a grant to CSA for one half-day per week of Dignity On Wheels services
- Provide free waste tank caps to RV owners to help ensure tanks are not leaking onto City streets
- Periodic 72-hour noticed cleansing of Crisanto Avenue and Latham Street
- Fund the purchase of a commercial washer and dryer for CSA and/or Hope's Corner
- Contract for Port-a-Pottis at Rengstorff Park and/or other location
- Provide grants for the additional insurance costs incurred by the organizations participating in a safe parking program
- Further discussion with the County and faith community regarding a rotating shelter model
- Split cost of Outreach Worker
- Fund a Case Worker via a "revenue sharing agreement" with the County for intense case management for Permanent Supportive Housing needs
- Direct staff to conduct further analysis and return to Council in early 2017, including the dumping station component
- Continued engagement with regional representatives and local partners, which would require ongoing staff time
