## 5.1 <u>Multicultural Festival Debrief</u>

- -Understanding the limits of free speech
- -Implicit/Unconscious bias
- -Human Trafficking and its implications
- -DACA/Immigrant Rights protection
- -Engaging in respectful dialogue/civil discourse workshop
