Motion – M/S Kamei / Cox - Carried 7-0 That the EPC adopt a resolution recommending that the City Council approve Zoning Text Amendments to Chapter 36 (Zoning Ordinance) of the City Code to update the Gatekeeper process of Division 12 and Division 13 of Article XVI and approve other minor code amendments based on the draft findings with recommended approval of the Zoning Text Amendments with the following modifications:

- -Minimum noticing radius of 500' for Gatekeeper hearings;
- -Project sites over two acres in total size require a noticing radius of 750' for Gatekeeper hearings; and
- -Increase the noticing time to fourteen days before a Gatekeeper hearing.
