MOTION: M/S - Grunewald/ Means - To approve a Resolution that an Annual General Adjustment of 2.6 percent shall be deemed banked in accordance with CSFRA section 1707(d) for Landlords to the extent and applicable only to Covered Rental Units that (a) were legally owned by the Landlord as of October 19, 2015 and continued to be owned by the Landlord until the banked increase is imposed, and (b) were continuously occupied by the same Tenant household since October 19, 2015 until the banked increase is imposed, and (c) were not subject to a rent increase between October 19, 2015 and December 23, 2016, and subject to the following constraints, the banked Annual General Adjustment of 2.6 percent authorized by this Resolution: (y) must be first imposed on or before August 31, 2020 or it is forfeit, and (z) may not be imposed prior to the adoption of a formal tenant hardship process as contemplated in CSFRA section 1707(d).
