The Commission was supportive of staff's proposal for providing additional certainty for land values and park land dedication in-lieu fees to developers. The Commission was supportive of staff's recommendation of one open space credit for Privately Owned Publicly Accessible open space (POPA) as long as the POPA was clearly available to the public through prominent frontage and adequate signage, and be just as welcoming and inviting to residents as any other parks in the City. The Commission requested staff review the list of elements and remove ones that are less likely to function successfully as publicly accessible open spaces (for example, the Community Gardens).
