Adopt Resolution No. 18627 of the City Council of the City of Mountain View to Amend the P-39 (North Bayshore) Precise Plan to include the parcel at 1555 Plymouth Street within the North Bayshore Precise Plan Gateway Character Area, revise the Bonus FAR Guidelines and Master Plan provisions, and make minor text and graphic updates, with modifications to the Bonus FAR Guidelines as proposed by staff in the Supplemental Memo dated 12/3/21.

4. Adopt Resolution No. 18628 of the City Council of the City of Mountain View Adopting the North Bayshore Gateway Master Plan.
