#### 3. STUDY SESSION

### 3.1 Affordable Housing at 87 East Evelyn Avenue

The purpose of this Study Session was to receive feedback from the Council on the Project Principles and Development Priorities for future affordable housing development on the former Valley Transportation Authority site at 87 East Evelyn Avenue, which would inform the Request for Qualifications and Request for Proposals process that staff would initiate to select an affordable housing developer for the site.

Mayor Ramirez disclosed he visited the site. Councilmember Lieber disclosed she visited the site. Councilmember Abe-Koga disclosed she visited the site and stated she served as a Valley Transportation Authority Board of Directors Ex-Officio Member. Councilmember Matichak, Vice Mayor Hicks and Councilmember Showalter disclosed they each visited the site on their own.

By consensus, the Council indicated support for the recommended Project Principles and Development Principles for affordable housing at 87 E. Evelyn including the proposed mix of residents, particularly a significant number of family units, the proposed approach regarding density and the proposed approach regarding the parking ratio.

A majority of the Council indicated support for the following: explore incorporation of wider sidewalks and tree buffers by the freeway, allow applicants to propose higher densities and taller buildings than the maximum range proposed by staff, require applicants to explore how they might collaborate with the owners of the adjacent site at 57-67 E. Evelyn to coordinate site plans and evaluate potential for master planning, allow applicants to propose publicly available and accessible ground floor uses and include a live/work preference if legally feasible.
