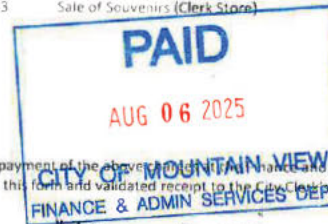

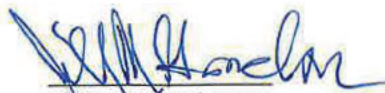

We completed a sewer line repair on **July 24th, 2024**, and during the course of our work, we determined that the **tree in question was the direct cause of the damage** to the existing sewer line.

Given this finding, we strongly recommend **removal of the tree** to help **prevent future damage** to both water and sewer infrastructure on the property. Left in place, the tree poses an ongoing risk of root intrusion and further costly repairs.

We hope this information assists in your decision regarding whether or not the tree should be removed. Please feel free to contact us if you have any questions or need further details.

#### Description of Work

##### SPRAY LINER:

We found a significant issue with your main sewer line. The existing 4-inch pipe, which is over 50 years old, has roots growing inside and a break, leading to frequent backups and sewage leaking into the foundation, potentially causing structural damage. Sewer lines have a limited lifespan, and at this age, replacement or repair becomes necessary to ensure proper functioning.

Our recommended solution is to apply an epoxy spray liner to the existing 4-inch pipe for a length of approximately 54 feet. This method involves inserting a flexible liner coated with epoxy resin into the damaged pipe and inflating it to conform to the interior shape. Once cured, the epoxy liner creates a new, seamless pipe within the old one, effectively sealing off any cracks, breaks, or root intrusions.

The benefits of this solution include:

- Minimal disruption to your property, as no digging or trenching is required.
- A long-lasting repair with a 20-year warranty from EJ Plumbing.

We replaced the sewer line from the house up to the property line via pipe bursting method with SDR 17 high density plastic with a 25 year warranty.

We also did an Epoxy brush coating for the main trunk line under the house from the two way clean out

2. We had to exposed sewer line at house and near side walk.

6. The process of pipe bursting will take a few hours depending on length of sewer line.
7. Once we finish pulling new 4" sewer line (SDR 17 pipe) we will install two way clean out on house side.
8. We will also install one way clean out on city side.
9. Once we test to make sure there are no leaks, we will back fill both holes with appropriate sewer boxes.
