RECOMMENDATION

Adopt a Resolution of the Rental Housing Committee of the City of Mountain View Adopting an Amended Meeting Schedule for Calendar Year 2024, as read in title only, further reading waived (Attachment 1 to the memorandum).

BACKGROUND

On November 8, 2016, Measure V, otherwise known as the Community Stabilization and Fair Rent Act (CSFRA), was passed by the voters. The stated purposes of the CSFRA are to promote neighborhood and community stability, healthy housing, and affordability for renters in the City of Mountain View by controlling excessive rent increases and arbitrary evictions to the greatest extent allowable under California law while ensuring landlords a fair and reasonable return on their investment and guaranteeing fair protections for renters, homeowners, and businesses. On September 28, 2021, the Mobile Home Rent Stabilization Ordinance (MHRSO) was adopted to protect mobile home residents from unreasonable rent increases while at the same time protecting the rights of park owners and mobile home landlords to receive a fair return on their property and rent income sufficient to cover increases in the costs of repairs, maintenance, insurance, employee services, additional amenities, and other costs of operation.

The Rental Housing Committee (RHC) has been assigned powers and duties to implement the CSFRA and MHRSO and has been meeting on a regular basis. On September 25, 2023, the RHC adopted its meeting schedule for calendar year 2024. However, in its meeting on October 21, 2023, the RHC deliberated on ways to increase review time between the publication of the RHC agenda and the RHC meeting, including the option of moving RHC meetings to another day of the week.

PROPOSED AMENDMENT TO MEETING DATE SCHEDULE

Staff reviewed the options for increasing review time between the publication of the agenda and the meeting and proposes to schedule RHC meetings on the fourth Thursday of the month (with the exception of November and December, which are scheduled on the second Thursday of the month), with agendas being published the Friday before each meeting. Tuesdays and Wednesdays are less viable options as other bodies, such as the City Council, the Environmental Planning Commission, etc., are held on those days as well as staffing limitations on those days.
