A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW  
AUTHORIZING TEMPORARY CLOSURE OF PARKING LOTS 4 AND 8 FROM  
7:30 A.M. THROUGH 2:30 P.M. ON SELECT SUNDAYS OCCURRING BETWEEN JANUARY 5, 2026  
AND FEBRUARY 8, 2026, NOT TO EXCEED FOUR SUNDAYS,  
FOR USE BY THE CALIFORNIA FARMERS' MARKETS ASSOCIATION

WHEREAS, the California Farmers' Markets Association is a growers' organization proposing to operate a certified farmers' market in accordance with California Department of Agriculture regulations in Downtown Mountain View; and

WHEREAS, the California Farmers' Market Association is willing to provide all necessary services to operate the market, including setup, cleanup, promotion of the temporary move from the typical location at the Mountain View Transit Center, coordination with the surrounding neighborhood regarding concerns and complaints, etc., and is able to meet City requirements for insurance, liability, etc.; and

WHEREAS, Mountain View City Code Section 19.67 prohibits obstruction from free use of any City-owned or controlled street or parking lot, or any adjacent sidewalk; and

WHEREAS, Sunday home games of the San Francisco 49ers football team at Levi's Stadium in Santa Clara will result in the temporary relocation of the farmers' market on game days to maximize the opportunity of public utilization of Santa Clara Valley Transportation Authority light rail transit to attend games. There is the potential for up to three additional Sunday home games in January 2026 based on the possibility of a postseason playoff appearance by the San Francisco 49ers football team; and

WHEREAS, Super Bowl LX will be held on February 8, 2026, at Levi's Stadium in Santa Clara and is anticipated to impact the Farmers' Market's use of the Transit Center parking lot. Closure of Lots 4 and 8 to facilitate game attendees' use of public transit is appropriate; and

WHEREAS, City-owned Parking Lots 4 and 8, in the blocks bounded by West Evelyn Avenue, Hope Street, Castro Street, and Villa Street, and West Evelyn Avenue, Hope Street, View Street, and Villa Street, respectively, are a suitable temporary location for the Sunday Farmers' Market; now, therefore, be it

RESOLVED: by the City Council of the City of Mountain View that, pursuant to Mountain View City Code Section 19.92, Parking Lots 4 and 8 are hereby temporarily closed from 7:30 a.m. through 2:30 p.m. on select Sundays occurring between January 5, 2026 and February 8, 2026,

Not to Exceed Four Sundays, as set forth in the recitals above and as may be amended and/or scheduled, to enable the California Farmers' Market Association to use Lots 4 and 8 for a farmers' market; and be it

FURTHER RESOLVED: that staff is hereby directed to post appropriate signage to notice the temporary closure of Parking Lots 4 and 8 and provide notification of select Sunday closure dates between January 5, 2026 and February 8, 2026, on the City website.
