

My name is Marni Weinstock and I am currently serving as the Mountain View Masters president. I have read through the city's proposed fee schedule and would like to comment on a few things.

First, our current fees listed for Eagle Pool are incorrect. We currently have been paying \$50/ hr based on a 3 year step up plan with the \$56 rate to take effect July 1.

More concerning to the team is the increase we will have to pay when we must move to Rengstorff (once Eagle closes for renovations in/around 2027), Why is it so significantly different from LAMVAC and other user groups when it previously wasn't? What is the justification for a higher cost to MVM? When we are forced to move, this will be a roughly 25% increase to our typical rent. And we do not know how long renovations to Eagle will take.

I hope that you are doing well. I think that you know me a bit by now - and know that I have the best of intentions. I am only trying to be helpful and see improvement in systems.

I did see this email and think that there is room for improvement by the city when sending something like this to the residents. I ran it through AI and this is what is mentions as ways the email might cause consternation.

• The actual proposed fee change amount is not stated. While the message directs residents to page 31 of the Proposed Fee Schedule, it doesn't clearly state how much the fee might increase (or decrease) from the current \$50 per year. This lack of transparency could cause anxiety as residents would need to look up the document themselves to understand the potential financial impact.

• No context about the scale or percentage of the potential increase. Residents would want to know immediately if this is a minor adjustment or a significant change to their garden plot fees.

• No timeline for when any approved fee changes would take effect. While it mentions the June 10th meeting, it doesn't specify when new fees would be implemented if approved.

• No explanation of the rationale behind the potential fee changes. The message doesn't provide any justification for why fees might need to be adjusted.

• Limited options for providing feedback. Only one email contact is provided, with no mention of opportunities for in-person feedback before the Council meeting or whether residents can speak at the June 10th meeting.

• No information about how to attend the Council meeting (whether in-person or virtually) to voice concerns directly.

• No reassurance about existing paid fees. Current plot holders who have already paid their \$50 might wonder if they would need to pay an additional amount if fees increase mid-year.
