A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2024,
DECLARING THE RESULT, AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Mountain View, California, on Tuesday, November 5, 2024, as required by law to elect four members to the City Council and submit to the voters Measure G relating to amending the City's Real Property Conveyance Tax Ordinance; and

WHEREAS, notice of the election was given in time, form, and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and votes were cast, received, and canvassed and the returns made and declared in time, form, and manner as required by the provisions of the Elections Code of the State of California; and

WHEREAS, the County Registrar of Voters canvassed the returns of the election and has certified the results to this City Council, and the results are received, attached, and made a part hereof as Exhibit A; now, therefore, be it

RESOLVED: that the City Council of the City of Mountain View does resolve, declare, determine and order as follows:

1. That the whole number of ballots cast in the City of Mountain View was 41,951.
2. That the names of the persons voted for at the election for Member of the City Council are as follows:

3. That the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit A.

4. That the City Council does declare and determine that Pat Showalter, Emily Ann Ramos, Chris Clark and John McAlister were elected as Members of the City Council for the full term of four years.

5. That the City Council does declare that a majority of the voters voting on Measure G relating to amending the City’s Real Property Conveyance Tax Ordinance voted in favor of the measure and that Measure G carried and shall be deemed adopted:

MEASURE G

Shall the measure to provide additional funding for services that protect local property values, including 9-1-1 emergency medical/disaster response; street, sidewalk and pothole repairs; affordable housing support; and other general government services, by raising the City of Mountain View's existing voter-approved property transfer tax, imposed on residential/commercial property sales above \$6,000,000 only, up to \$15.00 per \$1,000, generating about \$9,500,000 in locally controlled funding annually until ended by voters, with independent audits, be adopted?

6. That the City Clerk shall enter on the records of the City Council of the City of Mountain View a statement of the result of election showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) the offices to which each person was voted for; (4) the number of votes given at each precinct/voting center to each person; and (5) the total number of votes given to each person.

7. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the Office of the City Clerk.

Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected in accordance with Mountain View Charter Section 500.
