TITLE: **2024 Cal Cities Annual Conference Voting** 

**Delegate and Recommended Position for** 

the Conference Resolution

#### RECOMMENDATION

1. Designate Councilmember Ellen Kamei as the voting delegate for the General Assembly meeting at the 2024 Cal Cities Annual Conference.

- Authorize the voting delegate to cast a support vote for the Cal Cities 2024 Annual 2. Conference Resolution No. 1: Fair and Equal Treatment of All Government Officials at All Levels.
- Authorize the City's voting delegate to cast a vote at the Cal Cities Annual Conference to 3. reflect the position adopted by the City Council.

### **BACKGROUND**

The League of California Cities (also known as "Cal Cities") is holding its 2024 Cal Cities Annual Conference October 16 through October 18 in Long Beach, California. An important part of the Annual Conference is the Annual Business Meeting (during General Assembly), which will be held on October 18. Each member city has the right to cast one vote at the Annual Business Meeting on matters pertaining to Cal Cities policy. To vote, one voting delegate and up to two voting alternate(s) must be designated by action of the City Council and be present at the Business Meeting. The delegate and alternate(s) must be registered to attend the conference and obtain a voting card and register with the Credentials Committee at the Voting Delegate Desk in the conference registration area. The voting card may only be transferred between the voting delegate and alternate(s). Attachment 1 sets forth the voting guidelines for delegates and alternate(s).

This year, one policy resolution has been introduced and will be considered by the Governance, Transparency, and Labor Relations Policy Committee, who will meet on October 3 via Zoom to review the resolution and make a recommendation that will be sent to the Resolutions Committee. The Resolutions Committee will meet on October 17 to review the resolution and the recommendation of the Policy Committee. The Resolutions Committee consists of one representative from each of the Cal Cities caucuses, departments, divisions, and policy committees, as well as up to 10 additional appointments made by the Cal Cities President.

## **ANALYSIS**

Below is a summary of the resolution being considered for 2024, with detailed Cal Cities information included in Attachment 2. It is important to note that the City's vote on this resolution represents its comments on Cal Cities policy and not an action on behalf of Mountain View. Impacts may be applicable to Mountain View, and recommendations are summarized below. The voting delegate/alternate may gain new information at the conference that may help inform their vote as well.

# Cal Cities Resolution No. 1: Fair and Equal Treatment of All Governmental Officials at All Levels

## Summary of Resolution, Source, and Cal Cities Referral

Summary: This resolution states that the League of California Cities shall call upon the Governor of the State of California and the elected members of the California Legislature, including all members of the Senate and Assembly, to adopt the following policy:

"The California State Legislature shall not enact, and the Governor shall not sign into law, any law or regulation that applies solely to elected officials of California cities and counties, unless such law or regulation also applies equally to members of the California State Assembly and Senate. This prohibition shall not apply to laws or regulation affecting the inherent powers of the legislative branch under the California Constitution."
