##### 5.1 Historic Preservation Ordinance and Historic Register Update

Vice Chair Nunez read the item into the record.

Senior Planner, Ela Kerachian and Planning Manager, Eric Anderson gave an oral staff presentation and

responded to questions from the Environmental Planning Commission.

Vice Chair Nunez opened the public comment portion of the meeting asking if any members of the public wished to speak on this item.

Planning Manager Eric Anderson, Community Development Director Christian Murdock, Assistant Community Development Director Amber Blizinski, and Christina Dikas from Page & Turnbull responded to questions from the Environmental Planning Commission.

The Environmental Planning Commission discussed the eligibility criteria for properties to be included on the Historic Register.

Commissioner Donahue recused himself for discussion regarding whether 1181 Bonita Avenue should be included on the Historic Register, due to the proximity of his residence to the site.

The Environmental Planning Commission discussed 1181 Bonita Avenue site.

Commissioner Donahue rejoined the Environmental Planning Commission to discuss the remaining items.

**MOTION - MS - Dempsey/ Yin - To recommend to the City Council to:**

- Include in the draft ordinance the staff recommended eligibility criteria for the Mountain View Register of Historic Resources;
- Include all eligible sites (except 1181 Bonita Avenue, which is included in a separate vote) in the Mountain View Register of Historic Resources;
- Include in the draft ordinance the staff recommended program for ineligible properties that are currently on the Register, except to require a four-year period in which the property owner must submit an application to improve the site's eligibility and a total of seven years to complete the work, and to identify more proactive measures and incentives for Downtown properties;
- Include in the draft ordinance the staff recommended nomination, listing and delisting process, except to also ensure that properties may not be delisted due to owner negligence; and
- Include in the draft ordinance the staff recommended development review process for historic resources, except to also consider how interior floor area changes may also result in major changes to the character of historic resources, such as along Castro Street.

The motion carried by the following vote:

Anyone wishing to address the Commission in person must complete a yellow speaker card indicating the name you would like to be called by when it is your turn to speak and the item number on which you wish to speak. An individual speaker shall have up to three minutes to address the Commission. For any agenda item or for Oral Communications on nonagenda items, if there appears to be a large number of speakers, the Chair may reduce speaking time to no less than 1.5 minutes per speaker unless there is an objection from the Commission by majority vote.

If requested in advance of the public input portion of the agenda item to the Chair or dais staff, a speaker who represents five or more members of the public in attendance who complete cards but elect not to speak may have up to 10 minutes to address the Commission, if the Chair determines that such extension will reduce the total number of speakers who planned to speak.

An applicant and/or appellant for a zone change, precise plan or quasi-judicial hearing shall have up to 10 minutes to address the Commission and, with the consent of the Commission, two minutes of rebuttal at the conclusion of all public speakers.

The presiding officer may remove or cause the removal of any individual(s) for disrupting a meeting in accordance with California Government Code section 54957.95, as may be amended from time to time. In accordance with California Government Code section 54957.9, as may be amended from time to time, the Commission may order a meeting room cleared and continue in session in the event a meeting is willfully interrupted by a group or groups of persons so as to render the orderly conduct of the meeting impossible, and order cannot be restored by the removal of individuals who are disrupting the meeting.
