The RHC provided input on potential policy options for the valuation of habitability, maintenance and housing services petition decision rent reductions. The RHC conducted a straw poll on the following items:

- 2. Carries 5-1 in favor of the RHC communicating to Hearing Officers their desire to see detailed explanations of the methodology used to make the decision. This includes explanations of dollar amounts and percentages cited in the decision.
- 3. 4-2 in opposition of pursuing Option 2, adopting regulations that offer more detailed methodologies for hearing officers to consider when determining habitability and housing services rent reduction awards.
