TITLE: 2025 City Council Meeting Schedule

**RECOMMENDATION**—Approve the 2025 City Council meeting schedule.

## **BACKGROUND AND ANALYSIS**

As set forth in Mountain View City Code Section 2.1, City Council Regular Meetings are held on the second and fourth Tuesdays of the month. The following schedule proposes minor modifications to the City Council's regular schedule to avoid observed holidays and provide for a summer recess and a winter recess. City Council Special Meetings have been included to accommodate the Thanksgiving and Christmas holidays and to anticipate board, commission, and committee interviews, a Council retreat, and the Council appointees' annual review.

As long as at least a quorum of the members of the legislative body participates in person from a singular physical location in Mountain View clearly identified on the agenda, Councilmembers attending conferences that overlap with a Council meeting may avail themselves of the provisions of Government Code 54953 to attend the meeting using the "just cause" provision. Use of this provision is limited to two meetings per Councilmember per calendar year.

#### LEVINE ACT

Friday, December 26

California Government Code Section 84308 (also known as the Levine Act) prohibits city officials from participating in any proceeding involving a "license, permit, or other entitlement for use" if the official has received a campaign contribution exceeding \$250 from a party, participant, or agent of a party or participant in the proceeding within the last 12 months. A city official is similarly prohibited from accepting, soliciting, or directing a campaign contribution exceeding \$250 from a party, participant, or agent of a party or participant to any proceeding involving a license, permit, or other entitlement for use for 12 months after a final decision is rendered in said proceeding.
