Summary of Comparable Jurisdictions

This attachment provides a summary of comparable mobile home rent stabilized programs in 9 Bay Area Counties, including 36 jurisdictions (30 cities and 6 counties with rent stabilization programs) covering approximately 340 mobile home parks and 45,000 mobile homes.

Distribution of Jurisdictions and Mobile Homes with same AGA, Floor, and Ceiling Combination

Table 2A regroups the jurisdictions in Table 1 to show the number and percentage of jurisdictions with the same AGA, floor, and ceiling combinations. Many jurisdictions have combinations unique to their jurisdictions, while some combinations are shared by two or three jurisdictions. There are no combinations with more than three jurisdictions, indicating that a wide variation of combinations exist.

Mountain View has a combination of 100% CPI, 2% floor, and 5% ceiling (red box below). It is the only jurisdiction with this particular combination.

Table 2B shows the number and percentage of mobile homes covered under a particular combination. Again, Mountain View is the only jurisdiction with a combination of 100% CPI, 2% floor, and 5% ceiling (red box below). The rows highlighted in green show the three combinations that cover the most mobile homes. Note that the green row, left column with a combination of 75% CPI, 3% floor, and 7% ceiling reflect mobile homes from just one jurisdiction (San Jose).
