A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW ORDERING THE VACATION OF PUBLIC EASEMENTS AT 749 WEST EL CAMINO REAL

WHEREAS, on October 28, 2025, by its adoption of Resolution No, S	eries 2025,
the City Council of the City of Mountain View, pursuant to the provisions of Part 3 o	f Division 9
(Sections 8300 through 8374) of the Streets and Highways Code of the State of Califo	rnia (Public
Streets, Highways, and Service Easements Vacation Law), declared its intention to va	cate public
easements over the properties at 749 West El Camino Real; and	
WHEREAS, by the said Resolution No, which Resolution is incorp	
reference as if fully set forth herein, the City Council set Tuesday, November 18	
6:30 p.m. as the date and time for hearing all persons interested in or objecting to th	
vacation and directed the City Clerk to give notice of said hearing in the manner pro	escribed by
law; and	
WHEREAS, on November 18, 2025, the said public hearing was held and evi	
submitted to the City Council, bearing upon the present and prospective use of	the public

WHEREAS, this vacation is necessary for the development, Application No. PL-6884, for a Planned Community Permit and Development Review Permit to construct a mixed-use development comprised of 299 residential rental units, utilizing State Density Bonus Law, in a six-story building with 10,830 square feet of ground-floor neighborhood commercial space and atgrade podium parking above two levels of underground parking, a two-story 8,483 square foot bank building, a Provisional Use Permit for a roof top deck, and a Heritage Tree Removal Permit to remove 28 Heritage trees on a 3.05-acre site; now, therefore, be it

easements for transit shelter; and

RESOLVED: by the City Council of the City of Mountain View that, from all the evidence submitted, the public easements described in Exhibit A and Exhibit B, attached hereto and incorporated herein by reference, are unnecessary for present and prospective public uses and that, therefore, this body orders that the said public easements described herein be, and the same are hereby, vacated, subject to the conditions specified in this Resolution; and be it

FURTHER RESOLVED: that the City Council of the City of Mountain View, in accordance with Street and Highways Code Section 8324(b), finds that this Resolution shall not be recorded until the following conditions have been satisfied:

- 1. File with the City of Mountain View approved improvements plans, agreements, and performance bonds as a condition of approval for the project.
 - 2. New public easement(s) are dedicated as needed for the new transit shelter locations.

This Resolution shall be recorded concurrently with the Parcel Map in accordance with approved City recording instructions; and be it

FURTHER RESOLVED: that as finding of fact supporting its decision vacating the said public easements on 749 West El Camino Real, this body follows, and in addition, incorporates by reference, as if fully set forth herein, the Council report dated November 18, 2025:

- 1. The existing transit shelters within the easements are proposed to either be removed or relocated as part of the project.
 - 2. The existing easements are unnecessary for present or prospective public use.




