REPORT	TITLE:	SB 1 Streets Project, Project 21-30— Approve Plans and Specifications and Authorize Bidding

### RECOMMENDATION

- 1. Find that in accordance with the California Environmental Quality Act (CEQA) requirements, SB 1 Streets Project, Project 21-30, is categorically exempt as Class 1, Existing Facilities, and Class 4, Minor Alterations to Land, under CEQA Guidelines Sections 15301 and 15304.
- 2. Approve plans and specifications for SB 1 Streets Project, Project 21-30, and authorize staff to advertise the project for bidding.
- 3. Authorize the City Manager or designee to award a construction contract to the lowest responsive responsible bidder if the bid is within the project budget of \$1,300,000.

# BACKGROUND AND ANALYSIS

#### Pavement Improvement Program

The City's street network is 140.3 centerline miles in length and covers approximately 31 million square feet of pavement. The pavement improvement program includes maintenance and rehabilitation of this critical asset, including applying the appropriate pavement treatments of slurry seal, asphalt concrete overlay, or reconstruction. To preserve and maintain the City's roadway network, the City utilizes several funding sources, including State Gas Tax funding received from the Road Maintenance and Rehabilitation Account (RMRA), created by Senate Bill 1 (SB 1).




Figure 1: SB 1 Streets—Locations

On <u>February 22, 2022</u>, Council approved a professional services agreement with CSG Consultants, Inc. (CSG), for a not-to-exceed amount of \$130,000 to provide data collection, project design services, preparation of bid documents, and construction support services for pavement improvements at the following street locations for SB 1 Streets, Project 21-30 (see Figure 1):

- Location 1: Velarde Street between Bush Street and Anza Street.
- Location 2: Pamela Drive between Phyllis Avenue and Bay Street.

- Location 3: Bay Street between Pamela Drive and El Camino Real.
- Location 4: Doverton Square (intersecting Levin Avenue).
- Location 5: Katrina Way and Fairbrook Drive (intersecting Levin Avenue).

The project scope includes repairing localized roadway failures and applying slurry seal to roadways. The project will also provide active transportation improvements, including upgrading existing curb ramps to meet Americans with Disabilities Act (ADA) standards and adding or upgrading crosswalks with high-visibility striping.

### Paving for Castro Street Pedestrian Mall

On <u>October 11, 2022</u>, Council adopted Resolution No. 18718 and introduced an ordinance to establish a pedestrian mall on Castro Street between the east leg of West Evelyn Avenue and California Street. To prepare for implementation of the new Interim Pedestrian Mall operations in fall 2023, this segment of Castro Street needs to be resurfaced.




Figure 2: Castro Street Location 6

The pavement improvements for Castro Street required a similar design effort and expertise as the other locations in SB 1 Streets, Project 21-30. Therefore, on <u>March 14, 2023</u>, Council approved an amendment to CSG's Professional Services Agreement to include Castro Street as a sixth location (see Figure 2) and the following added scope of work:

- Removal of the vehicular lane striping from the roadway and application of slurry seal to the 100 to 300 blocks of Castro Street for the pedestrian mall;
- Installation of striping to create a central pedestrian walkway; and
- Pedestrian and vehicular channelization at the intersections of both West Dana Street and Villa Street with Castro Street.

In total, the project will rehabilitate approximately 213,000 square feet of pavement on the streets identified.

# **Environmental Clearance**

In accordance with the California Environmental Quality Act (CEQA), staff has reviewed the scope of this project and determined that it meets the classification for categorically exempt as both a Class 1, Existing Facilities, and a Class 4, Minor Alterations to Land. The proposed sites are existing streets that have no environmentally sensitive elements and are proposed for maintenance work. Staff recommends that Council make findings that in accordance with the CEQA requirements, the project is categorically exempt as a Class 1, Existing Facilities, and Class 4, Minor Alterations to Land, under CEQA Guidelines (Title 14, Division 6, Chapter 3 of the California Code of Regulations) Sections 15301 and 15304, respectively.

### FISCAL IMPACT

SB 1 Streets Project, Project 21-30, is funded with \$1,300,000 from the SB 1 Gas Tax Fund.

The estimated total project cost is as follows:

If Council approves the recommended actions, there is sufficient funding in Project 21-30 for the project. No additional appropriation is requested at this time.
